B. Background Information

Introduction

Karunamoyee Kali temple, founded in 1760 by Nandadulal RoyChowdhury, a descendent of Zaminder Sabarna RoyChowdhury, is the abode of spirituality since the beginning. It is also the symbol of equality across the entire population in and around Tollygunj, the place where the temple is located. People, from all backgrounds, irrespective of their social and financial differences find the same treatment in front of Mother Kali.

This equality of mankind got more refined in the lines of "Service to Man is Service to God." – as preached by Swami Vivekananda. The worship of the God, confined within the four walls of the temple, was not getting complete, unless the urge to worship the little Gods, living in the slums and running across the roads with empty stomach, came to the mind of the people here. The current priest, Ashok Roychowdhuri, and a few local residents like Satyajit Sarkar and others felt the pain of the poor kids around. It started with lunch and dinner for them twice a week from January, 2008. Food was cooked by Ashokda's wife and the kids started flocking around for a sumptuous meal in more numbers. A cook was appointed and the place was renovated to accommodate more kids. The frequency of food increased to thrice per week. Books were also distributed to the kids. A tutorial home which runs in the evening, has been organized at the temple only where few teachers provides voluntary service by imparting education to the slum children.

But this was just the beginning. Some of the kids expressed their strong interest in studies and the will to stand on their own feet someday was apparent in their bright eyes. They expressed the lack of support and love at home, where nobody is there to take care of them. This touched Ashok RoyChowdhury, Satyajit and others. They started dreaming of Ananda Ashram – a residential set-up for some of the kids from the next academic session of 2009. A 700 sq ft area was developed for the dormitory, kitchen and other facilities. Ananda Ashram was inaugurated on 1st Jan, 2009 with a purpose to give the best available opportunities to three (3) such kids so that they can stand on their own feet in future. The vision is to expand its service to more such kids – both poor and orphans in future.

'Amader Arpan' a social humanitarian organization, which serves the poor and unprivileged children has also extended their hands in this effort. They have been associated with the project from the initial planning stages and they have committed to provide not merely a financial support but a proper environment for the rearing up of the children.

Today they have people like Mr. Atanu Bhattacharya, Mr. Amitava Mukherjee, Mr & Mrs. Subrata Majumdar, Mr Aniruddho Bose, who have extended their help in all forms for realizing this dream.

C. Project location

The ashram is located at Karunamoyee, Tollygunge. A 700 sq ft room has already been constructed having a capacity of accommodating eight children & comprises a toilet as well. It has been partitioned into two, thus leading to an area of study room and a dormitory. Although we have a capacity of keeping eight children but initially we would admit three children , establish a process & system., groom them slowly & then slowly increase our strength. We have accordingly planned our activities, infrastructure & the resources keeping in mind of our final strength.

D. Aims and Objectives

Ananda Ashram plans to bear all the financial and other responsibilities in educating the kids till they graduate and stand on their own feet. They will be provided with the best possible schooling, health care, tuitions inside the ashram under the care and guidance of RoyChodhury, temple staff and anybody who volunteers to support this cause. The primary objective is to build complete men out of these little kids, so that they themselves can take care of more and more such deprived children, thereby serving the society at large.

In order to meet the objective, the following will be performed:

- i) Providing Food, clothing & shelter
- ii) Providing proper medical care
- iii) Providing education which includes admission to school, tutor, vocational training etc.
- iv) Providing facilities for sports and recreation.
- v) Introduction of a **House Brother** who would be with these children for 24 hours to monitor and supervise.

Induction to the Ashram

The Ashram will induct poor boys below the age of 10 years. The current set up is not capable to handle girls at the moment, though in future the Ashram will expand its service to the girls also. Orphans and poor kids with single parent or from vulnerable backgrounds will be given preference in selection procedure.

Schooling and Study At Home (Tutorship)

In order to be a part of the society, we understand the need of education & the importance of value system. Since these children would be coming from educationally weak background where formal education may or may not exist, Ananda Ashram will be taking special care for grooming them. Special tutor/teacher will be appointed so that all these three (3) children get proper attention in addition to their study at school. They will be admitted to the best possible schools around the Ananda Ashrm.

Health, Medical & Food system

We understand the importance of diet & feel that solid nutritious food should be provided to the children. Seasonal vegetables would be provided along with fruits & milk.

A medical clinic, which provides treatment to the poor living around the place is already existing inside the temple complex. The temple also has an ambulance. The existing facilities will be utilized to provide the basic healthcare to the children. Any emergency treatment can be supported through local hospitals and medical insurances.

Vocational Training and Extra-Curricular Activities

The boys will be provided with vocational trainings in their areas of interest so as to increase their employability in future also. They will be trained in basic computers, music and drawing. There will be facilities for games that can be played inside the temple complex also.

E. Budget

Total Budget is for the financial year 2009-2010 is Rs. 3,43,216 which includes the recurring cost as well for running the ashram & we have already collected & spent Rs. 2,19,016 against construction, panting, & furniture of the building.

Every inmate would be admitted to a good school and would be provided with all the basic facilities required to bring up a child. This includes food, clothes, education, proper environment, medical facilities etc.


